

#### Windom Community Council Monthly Board Meeting Minutes Thursday, March 9, 2023 (Meeting held via ZOOM videoconferencing)

Welcome/Call to Order: Pat called the meeting to order at 7:04 pm.

## City Council Ward 11 Updates, Councilmember Emily Koski:

- Highway 62 and Bloomington Avenue is still closed.
- Recycling guides mailed out, includes schedule and tips & tricks to create less trash.
- City will begin brush pile burns. None in Ward 11 but be aware.
- Tree Lottery—open until end of March. Be sure to submit your name. \$30 per tree.
- Winter Parking Restrictions still in effect. Cannot park on the even side of the street.
- The City is seeking applicants for its Community Commission on police oversight.
  - Civilian Commissioners serve as the City's review panelists, on a rotating basis, to review investigations of alleged police misconduct.
  - As panelists, they will have direct access to investigatory case files being reviewed and provide recommendations on the merits of misconduct and allegations that will be forwarded on to Chief O'Hara.
  - This work will take place during public meetings, which will provide residents the opportunity to observe the presentations, listen, and discuss.
  - Application deadline: March 26<sup>th</sup>
- Legislative directive went through (request for action) regarding a high level analysis of a potential program, which will include a fiscal analysis, evaluation of a web based interactive tool that would track and report on different winter maintenance programs such as: snow plowing and sidewalk snow removal, and a high level evaluation of current and pilot programs being considered.
  - City Council did not pass an implementation of any program, this legislative directive is just a request to do an analysis.
  - The analysis will be due in June.
  - Councilmember Koski will share the results of the analysis and seek feedback from the City's constituents.
- Land Use Rezoning Study
- Metro Inn
  - Project approved by the planning commission.
- Aqua City Motel
  - Potential demolition of building in the spring.
- Councilmember wishes to bring Windom and Kenny together in increasing housing, retail, and commercial space. Potential for three hundred units of housing in the area. Discussion with Bachman's as it owns the land.

- Next Ward 11 meeting is on April 11<sup>th</sup> at 7:00 pm. Location: Pearl Park
  - $\circ$   $\;$  Inviting interim director of safety teams (Office of Violence Prevention).
  - Will discuss alternatives to policing, navigators, and behavioral response.

#### Home Loan Improvement Program Update — Jim Hasnik (Center of Energy & Environment):

- Program success due to great end-of-year marketing! Excellent job!
- \$36,000.00 remaining in the program.
- Zero percent loan program
- There were bids in December, January, and one that will close sometime in March with a loan of \$6,400.
- Currently, two applications are being processed.
  - Zero bids or loan amounts as of now. Cost and sizes of the projects are unknown currently.

# Windom Public Crime & Safety Update — Jennifer Waisanen (Crime Prevention Specialist at the 5<sup>th</sup> Precinct):

- Property crimes:
  - Auto thefts: high risk makes are Kia and Hyundai vehicles.
- In Windom, report from 02/01/23—03/08/23: 24 police reports made.
  - Eleven vehicles were stolen.
    - Some of the thieves are kids. Many of the vehicles are dumped and abandoned in other precincts with no gas.
  - Two catalectic converters stolen.
  - o License plates stolen.
  - On March 4<sup>th</sup> at 3:47 am Wentworth Court. Shooting occurred at the two hundred Club. After investigating, officers discovered that the shooting suspects had been known to stay with a known occupant near Wentworth Court. They were able to make an arrest.

#### 4. SW Neighborhoods Associations Collaborative Agreement — Update (Mario)

- March 10<sup>th</sup>: Update on whether the collaborative will receive the \$20,000.00 grant/funding.
- To formalize, funding is needed:
  - Hire a consultant to help with that process.
  - Develop a BIPOC (Black, Indigenous, People of Color) focused program that unites the neighborhoods for its educational event.
- This sets the foundation for the collaborative to seek more funding from private foundations, the State of Minnesota, and/or other entities.

#### 5. NCR: Partnership Engagement Fund Application — Update (Mario)

- Year 2023, we cannot pursue the funding, but we will continue to work with the City and find another organization for next year's funding (2024).
- Continue to seek places to solicit to find funding.
